



5) Retail Income

Lot of products of IWELL has up to 20% price difference between MRP and DSP.

Any IWELL Direct Seller can sell products on MRP & Earn Differential income easily.

EXAMPLE-

Product = MRP - DSP = Retail Profit = 1199 -959 = 240

So You will get Retail Income 20% (Daily 2 Product sell you will get Rs. 480 Means you will get monthly 480 x 30 = Rs. 14400)







6) Repurchase Bonus



Repurchase

Point Value

7% of total Business Value of company in that month

EXAMPLE

If you have done retail 10000 BV & if Repurchase Point Value Rs. 300.

Then your Retail Income 20%= 2000

Repurchase Incentives

10x300=3000

+ Ambassador = 2500 Bonus 7500





Rules for Repurchase Income



All direct sellers who purchase product of 1000 BV in a particular month are awarded with 1 Repurchase Bonus Point.

The direct seller who does not purchase minimum 1000 B.V. & Non-members are not qualified for this Bonus.

Hence you can earn lot of money without joining anyone



7) Performance Incentive

NO	Group BV (Own + Downline)	Incentives

- -This incentive will be given to a direct seller when he or she has minimum won purchase of 250 BV in that month.
- -Slab percentage will be considered on cumulative group BV.
- -The incentive slab and percentage as below-

Total BV generated in that specific month is awarded totally. No carry forward system.



8) Ambassador Bonus

This incentive will be based on the Generation Tree.

There will be two criteria for qualifying for this income: 1)Has achieved the highest Slab of Performance Bonus.

2)In order to qualify for this Bonus, member needs to have minimum own self repurchase worth 500 BV in that month.

For the Ambassador Rank only the Fresh BV of all its legs will be considered as it is the first Rank.

For all other Ambassador Ranks, the BV of the other Leg in which the Ambassador Rank Direct Sellers does not exist, will be considered for Ambassador Bonus.

Incentive percentage will be dependent upon the Ambassador Rank as described below:



Ambassador Bonus Calculations

Rank	Qualification	Other leg Fresh BV	Incentives
Star Ambassador	Achieved highest slab of Performance bonus	25000	3%
Ruby Ambassador	2 Ambassador in any 2 different leg	15000	5%
Sapphire Ambassador	4 Ambassadors in 4 different legs. (one in each leg)	0	7%


Rules for Ambassador Bonus


After calculating the Incentive percentage, the incentive will be distributed to the Direct Sellers depending upon the Company's Turnover BV.

Ambassador Bonus = (Monthly Company Turnover BV * Incentive %for an Ambassador Rank)/ The same Rank Qualifiers.

It should be noted that a Direct Seller who achieves the Sapphire Ambassador Rank will not be required to bring fresh BV every month and will still continue receiving Ambassador Bonus.

1% of Current Month Company Turnover.




- 1. Age limit 18 to 60.

13) Home Shoppe Incentive

Home shoppe incentives will be calculated according to product category (Free/Bronze/Silver/Gold) of the delivered Package.
